- 2) A candidate with PCM in 10+2/PUC and 40% and above has to apply for only B.Sc in optometrist course. Whereas, a candidate with PCB is eligible to apply for all of the above course.
 - Duration of the Course: 03 (three) years followed by 01 year compulsory internship (as per the instructions of university/RGUHS).
 - Duration of ESIC Bond Service: One year (as per the instructions of ESIC Hqrs office)

- 3) The Eligibility of Insured Person for availing benefit under the "Insured Persons Quota" for his/her child/children would be **31.03.2024.**
- 4) The age of the dependent male 'Ward of IP' for eligibility under the 'Insured Persons Quota' should not be more than 21 years as on 11th Jan, 2025 (11/01/2025). The said date would not apply to dependent unmarried female ward of IP as per provisions of the ESI Act, 1948.
- 5) Number of seats under the Ward of IP Quota is given in the admission notice enclosed.
- 6) Reservation policy as per Central Government will be followed.
- 7) Applications to be submitted through **e-mail only** to <u>deanmc-gb.kar@esic.nic.in</u>, other means of submission will be not be considered.
- 8) Last date for receipt of applications to will be on 11.01.2025 by 12:59 PM.

- 1) The online/ offline "Ward of IP Certificate" already issued to the candidates from ESIC offices for admissions to MBBS/BDS/Nursing/ Para Medical course for the Academic Year 2024-25 only will be considered for admission to B.Sc AHS courses at this institution.
- 2) If a candidate has not obtained any "ward of IP certificate" he/she has to obtain the same by visiting the nearest RO/SRO/BO and apply for the admissions 2024-25 within the last date. Same will be informed to the concerned ESIC offices.

ADMISSION POLICY AND PROCEDURE FOR ADMISSION TO B.Sc IN ALLIED HEALTH SCIENCE COURSES (PARA MEDICAL COURSES) AT "ESIC INSTITUTE OF ALLIED HEALTH SCIENCES, KALABURAGI" KARNATAKA

- 1. The selection would be on merit based on the marks obtained in [10+2] or equivalent examination. The educational qualification and minimum eligibility for the B.Sc Allied Health Science courses is enclosed in the notification.
- 2. The duration of courses shall be of three (03) years followed by one year compulsory internship (as per RGUHS guidelines) for direct admissions.
- 3. A candidate should have completed age of 17 years (as per RGUHS guidelines) as on the date of publication of admission notification.
- 4. The candidates admitted to the said courses will not be paid any stipend during the duration of the course.
- 5. The candidate would be required to serve the ESIC (as per requirement of ESIC) for a period of one (01) year after successful completion of the course. In event of failure to do so, the candidate would have to pay a sum of Rs. one (01) lakh. The candidates would have to submit an undertaking to this effect at the time of admission to the course. ESIC may release the candidate from this commitment, based on its need. The candidate would be paid consolidated amount of Rs.20610/- p.m. during this period of service.
- 6. Tuition fee for the courses would be Rs. 4,000/- per annum and university fees of Rs. 3,950/- is additional subject to the instructions of university/RGUHS. Hostel fees and mess charges (actual) would also be additional. The fee structure is enclosed in Annexure-II.
- 7. Any candidate after admission desires to discontinue the course shall pay penalty of Rs.1000/- to ESIC and course cancellation fees as per the university (RGUHS) instructions.. Tuition Fee in such cases shall be forfeited.
- 8. ESIC Institute of Allied Health Sciences, Kalaburagi (Karnataka), being a 'non-minority self-financed' Institution in Government domain, would contribute 20 % seats to the Govt. of Karnataka for filling up; as are contributed by private Institutions. The balance seats would constitute "Insured Person's (IPs) Quota.
