- 2. Selected candidates must submit a security deposit fee of Rs. 10,000/-(Rupees Ten thousand only) as Demand draft drawn on any nationalized bank in favor of ESI Fund Account No. 1 payable at Kolhapur at the time of Joining, which is refundable after successful completion of contract and production of 'No dues certificate'; which would be forfeited towards administrative expenses if the candidate resigns without notice.
- 3. Candidates working in Govt. Service should produce NOC from their department at the time of interview.
- 4. All rules regulation as per ESIC HQRS circular will be allowed.
- 5. The recruitments are purely on contractual basis (1 year) and selected candidates will have no claim for regularization of the service in the hospital.
- 6. No claim for any service benefit like PF, Pension, Gratuity, Medical Allowance, Seniority, Promotion and any kind of leave will be admissible.
